1. Introduction

PRO-ENERGY is a transnational cooperation project, co-financed by the Cooperation Programme "Interreg V-B Balkan Mediterranean 2014-2020", under Priority Axis 2, Specific Objective 2.2 Sustainable Territories. The project aims at promoting Energy Efficiency in public buildings in the Balkan Mediterranean territory and to create a practical framework of modelling and implementing energy investments interventions, through specific ICT monitoring and control systems, as well as through energy performance contracting (EPC). The specific objective of PRO-ENERGY is to reduce by more than 20% the energy spending in public buildings of the participating entities in one year after the implementation of pilot actions.

Based on the above, Work Package 1 (WP 1) "Project Management and Coordination" aims to support the Development Agency of Evia in monitoring and implementation of the physical and financial progress of the project in terms of the programmed activities and actions, as well as the administrative, financial and technical management of the project, through the preparation of appropriate progress reports according to the specifications, guides and tools of the Program Interreg V-B Balkan Mediterranean 2014-2020.

Specifically, action 1.3 "Management and Coordination" includes the support in the drafting of reports, in the financial control of the project and in certification of expenses during audits.

This deliverable is the third Project Progress Report (Π 1.2.3) that covers the period between 01/04/2021 until 31/05/2021. During this period there was no verification of expenditures on behalf of the Development Agency of Evia. Further to the relevant communication sent by the Joint Secretariat of the Programme, the Development Agency of Evia submitted on the MIS declared expenditure for the period: 01/01/2020 until 27/04/2021. The total amount that was declared was 20.038,40 euro. Within the same period, the Development Agency of Evia contacted Unit C of the Managing Authority of the Programme in order to assign a First Level Controller for the verification of these expenses that is expected to take place within the next reporting period.

3. Other activities

No progress report was submitted during this reporting period. The next progress report will be submitted for the period starting from 01/01/2021-30/06/2021 in mid of July.

With regard to the activities that took place during this reporting period, the Development Agency of Evia with the support of the technical consultant finalised the project website on the basis of the specifications that were developed, as well as the social media pages (Facebook, Likendin and Twitter) adding relevant material linked to the progress made so far. Also, the Development Agency of Evia (DAE) participated in the Project meeting that was organised by the Lead partner on 06/04/21 in order to discuss technical issues with regard to the activities under WP3 and WP4 and set specific timeframes for the next period.

Against this background, DAE finalised the Joint Strategy and Action Plan for increasing energy efficiency through behavioural change under WP3 and also finalised the report for the identification of trainees and training needs on the basis of the results that came out from the survey that took place under WP4.

During this reporting period, DAE also participated in the 3rd Project meeting that took place on 27/05/2021 that was organised by the LB, in order to discuss for the progress of activities under all WPs and plan the timeframes as well as the possible prolongation of the project and relevant budget modifications required.

Finally, and on the basis of the agreed timeframes, DAE finalised the deliverables 3.4 and 3.5 under WP3, and the training curricula upon certain thematics agreed among the partners under WP4.
